3. What do you believe are the three primary responsibilities of this office?

4. What do you see as the greatest challenge IEA members will face in the next five years? What ideas do you have to address that challenge?

The continued attacks and attempts at dismantling public education will be the greatest challenge that IEA members will face in the next five years. Over 90 percent of Idaho's children attend public schools, which are already underfunded. It will take solidarity and collective voice to prevent vouchers or similar schemes from taking scarce funding from students in our Idaho public schools. With programs like these, resources are given to private schools without accountability measures. Taxpayer dollars should go only to public schools open to all students, not for-profit, private institutions that can choose their students based on economic status, academic achievement and disability status, among a number of other factors. Several states have already been subjected to this harmful legislation. Studies have shown that voucher programs spike taxes, exclude rural communities and do not improve student achievement and growth.

To address this challenge, we must continue to use our voices and make our stories known. Whether we make phone calls, send emails, write letters, testify at the legislature and/or show up in numbers, we need to hold our lawmakers accountable and make sure they understand the impact these decisions will make. In addition to this, I will make a concerted effort to continue my work to persuade and inspire members to donate to PACE. Together, we will continue to show up, speak out and do what's best for our students, our economy and the future of education in Idaho.

5. What is your plan for increasing membership and member engagement?

I often say that my role as a Building Representative in my local is one of the most challenging and rewarding positions that I hold. It has taught me everything that I know about the importance of having courageous conversations regarding the power of membership. I have a passion for building capacity and connecting with members. I believe that the number one priority in increasing membership and retaining valued members is building lasting, authentic relationships with the educators you work with everyday. When members trust you and know that your intentions are genuine, they begin to listen to the reasons why union membership is for them.
